B) Supplementary Regulations Art. 12.2.2 (modification)

"In the holding area, the service operations are the same permitted in a RSZ (2014 FIA WRC Sporting Regulations— Article 52) **no persons other than the drivers and the Officials on duty will be permitted. No work may be carried out except by the drivers themselves using the equipment on board of the car.**"

C) Supplementary Regulations Art. 12.5 - Penultimate paragraph (clarification)

For clarification this Article is modified as follows:

"The maximum time allowed to complete SSS1 will be 4 minutes. Any crew who fails to complete SSS1 within this maximum time or does not start SSS1 will occur ~~the penalties laid down in Article 46.2 of the 2014 FIA WRC Sporting Regulations~~ **a penalty of 4 minutes.**"

D) Supplementary Regulations Art. 12.9.1

Finish of the Rally and final Parc Fermé (erratum)

"The final TC of the Rally is ~~TC17D~~ **TC17C.** ..."

E) Supplementary Regulations Art. 12.11 and Bulletin 3 (update)

Permitted early Check-in

It is clarified that early check-in is only permitted at TC9C, TC13C and TC17C.

F) Supplementary Regulations Art. 12.18 (new)

Regroup Sassari (Sunday, 8 June 2014)

No Team personnel will be admitted at / or in the Sassari Regroup. No Media Zone will be provided in front of the Regroup.

G) Supplementary Regulations Art. 12.19 (new)

Upon the arrival in front of TC9A, TC11A and TC13A and after completion of the Media requirements, the drivers are permitted to walk to their service bay and receive food and drinks there.

H) 2014 FIA WRC Sporting Regulations

Following the decision of the FIA World Rally Championship Commission in the last meeting of 28 May 2014, the following Article is re-introduced in the 2014 FIA WRC Sporting Regulations with immediate application:

"46.2.2 However, should the first special stage or super special stage that is missed be:

- that run as Section 1 when followed by an overnight regroup before Section 2, or
- the last stage before an overnight regroup, the penalty will be 10 minutes.

This 10 minutes penalty can be applied only once in a rally."
