### SUPPLY CONDITIONS OF TIRES

#### WRC 1 & 2 TEAMS AND EVENT COMPETITORS

Dear TEAM/COMPETITOR,

We are pleased to specify here below the order procedure for TESTING and for the EVENTS.

##### 1. COMPANY DATA

Only at the first order (and in case of changes to the Company details), please fill in the attached Company details **FORM A**.

##### 2. HOW TO ORDERING THE TIRES ?

The COMPETITORS must specify the type and the quantity of the TIRES.

##### 3. TIMING TO ORDER THE TIRES AND DELIVERY LOCATION

TIRES for TESTING and for EVENT will be ordered SEPERATELY no later than 4 (four) weeks (European events) and 10 (ten) weeks (Overseas events) from the delivery date indicated on our **FORM B** provided that the delivery schedule and the quantity of TIRES are confirmed by CEERTA in writing the following 7 business days, In the absence of CEERTA's written confirmation within 7 business days, the TEAMS's order will be considered as **NOT CONFIRMED** by CEERTA.

The Tires for TESTING will be at disposal at the CEERTA after payment and the shipment will be organized by the COMPETITOR.

The Tires for the EVENT will be supplied directly at our technical base in the servicepark.

On the following EVENTS (Mexico, Argentina, Australia), the Tires will be leased by CEERTA to the competitors. At the end of these events, the competitors have to return those Tires used and new. Only the used Tires will be invoiced to the competitors as well as the not returned Tires. Moreover, a payment of a caution of 50,00 € (VAT not included) will be invoiced per Tire leased and will be refund at the end of the event in case the Tires are returned to CEERTA.
